

**Terms and Conditions of the “Yo‘ldosh” Tariff Plan in the Prepaid System for Drivers and Couriers
Connected to Yandex Pro**

Additional Information

- The tariff plan is available for new activations and migrations (MNP) exclusively through a Deeplink in the Yandex Pro application in the Prepaid system. In other words, activation is available through the button/link in the Yandex Pro application, which redirects users to the Ucell Mobile Application where all terms and conditions are provided. The tariff is also available in Ucell sales offices throughout the country, upon presentation of the Deeplink in the Yandex Pro application.

Monthly subscription fee deduction and allowance allocation:

- The subscriber's tariff activation date is considered the monthly subscription fee deduction date.
- Upon a new activation, the monthly subscription fee is charged in full (without proration), and all allowances are granted in full, provided that the subscriber's balance is sufficient.
- If the balance is insufficient or negative, the monthly subscription fee is not deducted, the included allowances are not granted, and no debt is created on the subscriber's account.
- The next monthly subscription fee is deducted once every month from the date of the last successful subscription fee deduction.
- The next subscription fee deduction date is the date of the last successful subscription fee deduction under the tariff plan.
- The monthly subscription fee and allowance allocation are performed between 00:00 and 08:00 (the exact deduction time is not fixed). The subscriber must have sufficient funds in the account for the subscription fee to be deducted in full.
- The monthly subscription fee is charged once a month from the date of the last successful deduction of the monthly subscription fee under the tariff plan. The date of the next monthly subscription fee deduction is the date of the last

successful subscription fee deduction under the tariff plan (if the subscription fee deduction date is the 31st day of the month and the following month has 30, 29 or 28 days, the next monthly subscription fee will be deducted on the 30th day of the month or on the 28th/29th day of February. If the subscription fee under the tariff plan is paid on time (the subscriber's number remains continuously in the active status), the subsequent monthly subscription fee will be deducted on the 31st day of the month).

- If, at the time of the monthly subscription fee deduction, the subscriber's balance is insufficient to cover the subscription fee, the subscriber's number will be blocked. The subscription fee will not be deducted until the subscriber's balance is sufficient to cover the monthly subscription fee in full.

- The monthly subscription fee will be deducted immediately after the subscriber's balance is replenished with a sufficient amount to cover the monthly subscription fee in full. Once the subscription fee has been deducted, the subscriber's number will return to the active status and the allowances provided under the tariff plan will be assigned. Thereafter, the subscription fee will be deducted according to the subscriber's new monthly billing period, i.e. once every month from the date of the last successful subscription fee deduction under the tariff plan.

Terms for the Provision of the Monthly 5G Internet Allowance

- The 5G Internet allowance provided under the tariff plan is available and consumed only within the 5G network.
- Once the allocated 5G Internet allowance has been fully consumed, Internet usage in the 5G network shall be charged in accordance with the current terms and conditions of the tariff plan.
- The 5G Internet allowance is not available to subscribers while roaming.
- As an additional 5G Internet allowance is provided under the "Yo'ldosh" tariff plan, the "5G" service is activated automatically.
- The 5G Internet allowance is unavailable while the subscriber's number is in the blocked status.
- When Internet is shared via a smartphone hotspot or other devices, the allocated 5G Internet allowance will be available only if the generated Internet requests require significant data transfer and high Internet speed.
- When using proxy servers or VPN connections, Internet traffic will not be deducted from the allocated 5G Internet allowance.

Terms for the Provision of Unlimited Internet Traffic for Ucell TV

- Upon new activations and migrations (MNP) to the "Yo'ldosh" tariff plan, access to the following subscriptions within the "Ucell TV" service is provided by default:

Yo'ldosh	"Ucell TV" – unlimited access to UzMTRK channels (state television channels of the Republic of Uzbekistan).

- If the subscription fee under the tariff plan has not been successfully deducted, access to the respective TV channels within the "Ucell TV" service shall be restricted.
- The "Ucell TV" service is available only within the territory of the Republic of Uzbekistan.
- The "Ucell TV" service is available both via the Ucell mobile network and via the networks of any other mobile operator or Internet service provider, as well as through any Wi-Fi network. Internet traffic consumed via another mobile operator or Internet service provider shall be charged in accordance with the applicable terms and conditions of such operator or Internet service provider.
- When using the "Ucell TV" service via proxy servers, VPN services, or intermediary websites, Internet traffic shall be charged in accordance with the Ucell Internet tariff rates under the terms and conditions of the tariff plan, or deducted from the balance of the subscriber's active Internet package available for all destinations.
- An active Internet connection is required to watch the included TV channels online.
- Since access to TV channels within the "Ucell TV" service is provided by default, the purchase of certain paid subscriptions with access to TV channels is restricted under the "Yo'ldosh" tariff plan.

Terms for the Provision of Unlimited Internet Traffic for Yandex Plus

This is a single subscription that includes Yandex Music, Kinopoisk, Yandex Books, as well as cashback in the form of Plus points under the Yandex Plus Cashback loyalty program.

How to activate the Yandex Plus subscription:

Activate Yandex Plus to start enjoying all the benefits of your subscription. To do so:

- Go to <https://plus.yandex.uz/ucell>;

- Enter your phone number;
- Sign in using your Yandex ID.

Once completed, you will gain access to Yandex Music, Yandex Books, and cashback in the form of Plus points across Yandex services as part of your Yandex Plus subscription.

Terms

- Access to Yandex Music, Kinopoisk, Yandex Books, and Plus points cashback across Yandex services as part of the Yandex Plus subscription is available under the "Yo'ldosh" tariff plan, provided that the tariff plan subscription fee has been successfully deducted.
- When signing in to Yandex Music, Kinopoisk, and Yandex Books, the subscriber must use the Yandex ID linked to the subscriber number under the "Yo'ldosh" tariff plan. The subscribed Yandex Plus service must be activated on the plus.yandex.uz/ucell webpage.
- If the tariff plan subscription fee has been successfully deducted, the Yandex Plus subscription will be assigned for a period of 30 days from the date of its activation. If there are insufficient funds in the subscriber's account to pay the tariff plan subscription fee, the Yandex Plus subscription will automatically switch to the Pending Payment status and will be automatically renewed for the next 30 days as soon as the subscriber's account balance becomes sufficient to cover the subscription fee. Upon successful deduction of the monthly subscription fee, the subscription validity period shall be calculated from the date of its last assignment.
- Under the "Yo'ldosh" tariff plan, Internet traffic generated while using the Yandex Go, Yandex Music, Yandex Books, and Kinopoisk applications is not deducted from the Internet packages included in the tariff plan.
- When using the Yandex Go, Yandex Music, Yandex Books, and Kinopoisk applications while roaming, Internet traffic shall be charged in accordance with the applicable roaming zone tariffs.
- When using services included in the Yandex Plus subscription through proxy servers, VPN services, or intermediary websites, Internet traffic shall be charged according to the Ucell Internet rates under the tariff plan, or deducted from the balance of the subscriber's active Internet package available for all destinations.
- To avoid unnecessary Internet traffic consumption after activating the service, the subscriber should terminate the current Internet session by disabling mobile data and then re-enable the Internet connection.
- A subscriber may have multiple active Yandex Plus subscriptions. For example, a subscriber may have previously activated a subscription paid for by the subscriber's bank card. In such a case, a subscription paid for by other payment methods shall be managed through the Yandex Plus website in accordance with the Yandex Plus Subscription Terms and Conditions available at: https://yandex.ru/legal/yandex_plus_conditions/.
- If the subscriber switches to another tariff plan ("Maqsad" tariff plan), all Yandex Plus service features shall remain available until the expiration of the cancelled subscription. During this period, Internet traffic generated while using the Yandex Go, Yandex Music, Yandex Books, and Kinopoisk applications shall be charged in accordance with the subscriber's tariff plan or deducted from the balance of the subscriber's active Internet package available for all destinations.
- When the Restart service is used under the "Yo'ldosh" tariff plan, access to the services included in the Yandex Plus subscription is reset, and new access is granted in accordance with the terms and conditions of the tariff plan. Subscription to the standalone Yandex Plus service ("Paid Subscription" and "90-Day Free Subscription") is not available under the "Yo'ldosh" tariff plan.
- The Yandex Plus subscription does not provide access to the entire content catalogue available on the Kinopoisk service.
- Access to the Yandex Books service for subscribers is provided in accordance with the promotion terms available at: https://yandex.ru/legal/plus_x_books/ru/.
- Yandex Go: As part of the subscription, users receive cashback in the form of Plus points for rides booked through the application in accordance with the terms of the "Points for Rides via the Yandex Go Application" promotion: https://yandex.ru/legal/uz_ball_go/.
- By subscribing to the "Yo'ldosh" tariff plan, the subscriber confirms acceptance of the Yandex Plus Subscription Terms and Conditions. The detailed Yandex Plus Subscription Terms and Conditions are available at: https://yandex.ru/legal/yandex_plus_conditions/, and the Yandex Plus Cashback Loyalty Program Terms and Conditions are available at: https://yandex.ru/legal/plus_loyalty/ru/.
- When re-registering a subscriber number, the Yandex Plus subscription must be activated on the plus.yandex.uz/ucell webpage.
- By default, smartphones consume mobile Internet traffic in the background for system updates, application updates, synchronization of widget data (weather, calendar, etc.) and social media data, as well as analytics services (Google, google-analytics.com, googletagmanager.com, gstatic.com, stats.g.doubleclick.net). Internet traffic generated for

these purposes shall be charged in accordance with the Ucell Internet rates under the tariff plan, or deducted from the balance of the subscriber's active Internet package available for all destinations.

- The terms for unlimited Internet traffic provided as part of the services included in the Yandex Plus subscription do not apply when Internet traffic is shared via a smartphone hotspot (Hotspot) or other devices.

Blocking Conditions

- LIVE ZERO: Even with a zero balance, all communication services remain available to you!***

- The subscriber's number shall be blocked if there are insufficient funds in the account at the time of the monthly subscription fee deduction, even if the account balance is positive, or if the account balance is negative and the relevant additional services are enabled.

- While the subscriber's number is in the blocked status, changing the tariff plan is not available.

- If the subscriber's balance is sufficient to cover the subscription fee for another available tariff plan, plus the tariff change fee (where applicable), the subscriber may change the tariff plan using any of the available methods.

- While the subscriber's number is in the blocked status, the remaining allowances of previously purchased monthly Internet packages remain available until their expiration date (provided that a remaining balance is available).

- Monthly allowances under the tariff plan are assigned only after the monthly subscription fee for the current billing period has been successfully deducted. Any unused monthly allowances assigned during the current billing period are not carried over to the next billing period.

- To avoid misunderstandings, subscribers are strongly advised to top up their account in advance with a sufficient amount to cover the monthly subscription fee in full and to verify that the tariff plan allowances have been assigned using the Ucell mobile application or the *100# USSD request.

- Once the monthly allowances provided under the tariff plan have been exhausted, outgoing calls and SMS messages shall be charged at the out-of-bundle rates specified in the tariff plan.

- Once the monthly Internet allowance for all destinations provided under the tariff plan and any additional Internet packages has been exhausted, Internet access shall be suspended. The subscriber will receive an SMS containing a link to restore Internet access. To continue using the Internet, the subscriber must select one of the available options under which Internet services will continue to be provided:

- Refresh the tariff plan allowances (activate the Restart service);
- Purchase an Internet package;
- Activate mobile Internet at the out-of-bundle rate of 1 MB;****
- Change the tariff plan.

**** If the subscriber chooses the option to use mobile Internet at the out-of-bundle rate per 1 MB and subsequently purchases a Monthly Internet Package, once the allowances of the additional package have been exhausted, Internet traffic will continue to be charged at the out-of-bundle rate per 1 MB in accordance with the tariff plan terms until the next successful deduction of the monthly subscription fee.

The subscriber may also activate the "Mobile Internet at the out-of-bundle rate per 1 MB" option independently by dialing the *727# USSD code.

If Internet access is suspended, subscribers wishing to use payment system applications in offline mode must disable mobile data on their device to ensure the proper operation of such applications.

Please note:

- To avoid misunderstandings, subscribers are strongly advised to verify that the tariff plan allowances have been assigned using the *100# USSD request or the Ucell mobile application before using the allowances provided under the tariff plan. Until the minutes, SMS, and MB allowances have been assigned, services shall be charged at the out-of-bundle rates specified in the tariff plan.

- Minutes provided under the tariff plan cannot be used for calls to information and entertainment services or international destinations.

- The allowances provided under the tariff plan are not available to subscribers while roaming (except for roaming traffic allowances).

- Subscribers of the "Yo'ldosh" tariff plan may use the following services: Number Retention, New Monthly Internet Packages, TAS-IX Internet Packages, the Al Chiroq promotion (MB and SMS packages only), and the Traffic+ service.

- The following services and packages are not available to subscribers of the "Yo'ldosh" tariff plan: Convenient Minutes, Convenient On-Net, Convenient Nationwide, Daily Internet Packages, Weekly Internet Packages, Daily SMS Packages, Monthly 4G Internet Packages (including the corresponding packages available under the We Value You loyalty program), Night Internet, Night Internet Packages, Try 4G at Night, Internet MEGA BOOM, Custom Package, Hourly Internet, Maximum Access, Megabytes Return, and the We Value You and U+ loyalty programs.
- The "You Have Been Called" service is provided automatically and free of charge upon activation of or migration (MNP) to the "Yo'ldosh" tariff plan.
- Subscribers using Internet services are advised to review the additional information regarding the funds reservation system and the operational features of the 4G network.

Restart Service Terms and Conditions

1. The Restart service may be activated via the Ucell mobile application or by dialing the *222# USSD code.
2. The Restart service is available only to subscribers whose numbers are in the Active status.
3. The Restart service enables subscribers to independently initiate the deduction of the monthly subscription fee and receive the monthly allowances provided under the tariff plan. Upon successful activation of the Restart service, the subscriber's monthly billing period is reset based on the date of the last successful activation of the service.
4. Upon activation of the Restart service, the full monthly subscription fee is deducted from the subscriber's balance, and the full monthly allowances provided under the subscriber's tariff plan are assigned. Thereafter, the monthly subscription fee shall be deducted according to the subscriber's new monthly billing period.
5. To activate the Restart service, the subscriber's balance must contain sufficient funds to cover the monthly subscription fee in full. After the Restart service is successfully activated, the monthly subscription fee will be deducted and the full tariff plan allowances will be assigned.
6. Any remaining allowances (SMS and MB) previously assigned under the tariff plan shall be reset upon successful activation of the Restart service.
7. The Restart service cannot be activated on the day the monthly subscription fee is scheduled to be deducted.
8. The Restart service may be used only once per calendar day (from 00:00 to 23:59 of the current day).

Note:

By default, smartphones consume mobile Internet traffic in the background for system updates, application updates, synchronization of widget data (weather, calendar, etc.) and social media data, as well as analytics services (Google, google-analytics.com, googletagmanager.com, gstatic.com, and stats.g.doubleclick.net). Internet traffic generated for these purposes shall be charged in accordance with the Ucell Internet rates under the tariff plan or deducted from the balance of the subscriber's active Internet package available for all destinations.
